

## ► FACILITY

KES Care Center moved its headquarters into a newly renovated facility in late 2012. The 5,000 sq. ft., two-story, space houses the company offices on the second floor and a spacious, yet private day habilitation program area on the first floor. The property has perimeter wrought iron fencing and a state-of-the-art security system with alarm and video monitoring throughout.

The facility is conveniently located in the commercial section of a quiet residential area near a park and in close proximity to a library that offers various activities, KES Care Center owns a 14-passenger bus equipped with wheelchair access to provide round-trip transportation for clients residing in the various group homes operated by KES Care.

## KES CARE CENTER

is a Home and Community-Based Service (HCS) agency provider funded through the Department of Aging and Disability Services.

### > PHILOSOPHY

Our philosophy is based on the principle of providing Knowledgeable, Exceptional, and Supportive services to those who are intellectually disabled regardless of race, religion, creed, national origin, age, sex, or level of disability.

### > GOAL

We want to assist all of our clients in reaching their optimal level of functioning.

### > ELIGIBILITY

To receive services through **KES Care Center**, individuals must meet the financial eligibility criteria established by the Department of Aging and Disability Services. Individuals must have a diagnosis of being intellectually disabled before age eighteen. They must also be eligible for Supplemental Security Income (SSI) and Medicaid benefits.



### > SERVICES

We provide services in accordance to the guidelines set by the Home and Community-Based Service (HCS) program. The services offered are as follows:

### > DAY HABILITATION

We offer a day habilitation program which currently services adults who are intellectually disabled. This program is housed on the first floor of the building located at 1621 Pleasantville Drive.

The 2,500 sq. foot space includes a project/activity area, a computer room, a dining area, fully-equipped kitchen and pantry, a TV viewing area, and restrooms with shower facilities. KES Care Center's day habilitation program assists consumers with day-to-day living skills, provides assistance with independent living skills, and helps with medication, personal care and hygiene skills. KES Care Center also aids consumers with their money management skills and community integration activities.

The consumers of our day habilitation service enjoy community outings including bowling, picnics in the park, trips to the movie theatre, going out to eat, as well as shopping in the community. They also participate in arts and crafts. KES Care Center day habilitation service meets the guidelines as defined by the Home and Community-Based Service (HCS) program.
